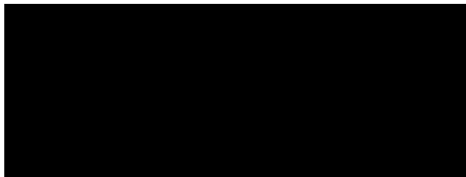

I am writing in relation to your application made under the *Freedom of Information Act 1991* (the FOI Act) in which you requested access to the following:

*"All audio recordings and transcripts of all 000 calls received in relation to the Sherwood bushfire which commenced on Saturday, 6 January 2018 in the vicinity of Dark Island Well Road and Emu Flat Road, Sherwood SA 5267."*

In accordance with the requirements of Premier and Cabinet Circular PC045, details of your FOI application, and the documents to which you are given access, may be published in the agency's disclosure log. A search of files has been conducted and twelve (12) audio recordings were located that are within the scope of your application. The audio recordings have been copied onto disk as requested.

In respect of each audio recording, I have determined as follows:

I have determined that the audio recordings should be released in part. In regard to the audio recordings, the parts to which I have not granted you access are the names, telephone numbers or addresses of callers. I have determined that this information is exempt under clause 6 (1) which reads:

*"A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead)."*
